RESOLUTION NO. 10-18

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE WEST HEMPFIELD TOWNSHIP REMOVING LAKE GRUBB NATURE PARK FROM THE LIST OF TOWNSHIP OWNED AND/OR OPERATED PARK AND RECREATION FACILITIES WHERE DOGS ARE PERMITTED

WHEREAS, Chapter 92 of the Code of Ordinances provides regulations for the use of Township property including, but not limited to, regulations governing animals; and

WHEREAS, Section 92-3.A(2) of the Code of Ordinances provides that dogs are permitted on Township properties where the Board of Supervisors has, by resolution, authorized dogs to be brought onto such property and the Township has posted the property with signs stating dogs are allowed; and

WHEREAS, the Board of Supervisors desires to allow dogs to be brought onto Township owned and/or operated park land subject to the requirements of Section 92-3.A of the Code of Ordinances; and

WHEREAS, on August 7, 2018, the Board of Supervisors adopted Resolution 9-18 authorizing dogs to be brought onto all Township owned and/or Township operated park and recreation facilities.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Board of Supervisors of the Township of West Hempfield, Lancaster County, Pennsylvania, as follows:

Section 1. The Board of Supervisors hereby removes Lake Grubb Nature Park from the previously approved list of Township owned and/or Township operated park and recreation facilities on which dogs are authorized to be brought onto.

Section 2. The Board of Supervisors hereby continues to authorize dogs to be brought onto Township owned and/or Township operated park and recreation facilities including Cedar Bluff Park, Fairview Park, Ironville Park, Silver Spring Park, Bridge Valley Park, Falcon Ridge Park, Eagle's View Park, and Murry Ridge Park. All persons bringing dogs onto such park and recreation areas shall comply with all provisions of Chapter 92.

Section 3. The Board of Supervisors reserves the right to revise the list of park and recreation areas at which dogs will be permitted at any time.

Section 4. In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Resolution, it being the intent of the Board of Supervisors that the remainder of the Resolution shall be and shall remain in full force and effect.

Section 5. This Resolution shall take effect and be in force immediately.
