**RESOLUTION No. 2-2021** 

## A RESOLUTION OF THE WEST HEMPFIELD TOWNSHIP MUNICIPAL AUTHORITY, LANCASTER, PENNSYLVANIA, ESTABLISHING DISCOUNTS FOR THE 2021 STORMWATER MANAGEMENT FEE.

WHEREAS, on February 2, 2021, the West Hempfield Township Municipal Authority adopted Resolution 1-2021 establishing a fee for storm water collection and management; and

WHEREAS, West Hempfield Township (the "Township") has applied for and has received grant funding for certain storm water management projects; and

WHEREAS, the Township can allocate funds which the Township anticipates receiving under the American Rescue Plan Act to storm water management projects, which can serve as matching funds for the grant the Township sought and received; and

WHEREAS, the Township's undertaking of storm water management projects using the funding the Township has received for storm water management infrastructure and improvements will enable and will require this Authority to further evaluate future storm water management projects; and

WHEREAS, the change in the timing of this Authority's storm water management projects will decrease the revenue this Authority requires in 2021; and

WHEREAS, this Authority desires to reduce the storm water management fee established by Resolution No. 1-2021 for the bills to be sent on July 1, 2021 only.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the West Hempfield Township Municipal Authority, Lancaster County, Pennsylvania, that the Authority establishes the following:

<u>Section 1.</u> The fees identified in Section 5 of Resolution 1-2021 are hereby reduced for the 2021 billing cycle only as follows:

- a) Residential: All Single-Family Residential Properties will pay \$54.00.
- b) <u>Agriculture</u>: All Agricultural properties with one ERU will pay \$54.00. All Agricultural properties over one ERU will pay \$36 per ERU. All agricultural properties over one ERU for which an approved conservation plan is provided to the Township, along with certification that the plan has been implemented, will be reduced to one ERU.
- c) Non-Residential/Non-Agricultural: All Non-Residential/Non-Agricultural properties with one ERU will pay \$54.00. All Non-Residential/Non-Agricultural properties over one ERU will pay \$36 per ERU.

The original fees identified in Resolution 1-2021 shall be in effect for billing cycles after 2021, unless further amended by a future Resolution.

<u>Section 2.</u> In the event any provision, section, sentence, clause, or part of this Resolution shall be held to be invalid, illegal, or unconstitutional by a court of competent jurisdiction, such invalidity, illegality, or unconstitutionality shall not affect or impair the remaining provisions, section, sentences, clauses, or parts of this resolution, it being the intent of the West Hempfield Township Municipal Authority that the remainder of the Resolution be and shall remain in full force and effect.

<u>Section 3.</u> This Resolution shall take effect and be in force immediately.
