**ORDINANCE NO. 2-23**

---

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE TOWNSHIP OF WEST HEMPFIELD, CHAPTER 139, VEHICLES AND TRAFFIC, TO ESTABLISH SPEED LIMITATIONS ON NOLT ROAD AND SILVER SPRING ROAD.

BE AND IT IS HEREBY ORDAINED AND ENACTED by the Board of Supervisors of the Township of West Hempfield, Lancaster County, Pennsylvania, as follows:

Section 1. The Code of Ordinances of the Township of West Hempfield, Chapter 139, thereof, Vehicles and Traffic, §139-54, Schedule I: Speed Limits, shall be amended by inserting following speed limitation in alphabetical order:

<u>Name of Street</u>	<u>Speed Limit</u>	<u>Location</u>
Nolt Road	25 miles per hour	Entire length
Silver Spring Road	25 miles per hour	Nolt Road to a point 700 feet west

Section 2. All other sections, parts and provisions of the Code of Ordinances of the Township of West Hempfield shall remain in full force and effect as previously enacted and amended.

Section 3. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of the Board of Supervisors that the remainder of the Ordinance shall be and shall remain in full force and effect.

Section 4. This Ordinance shall take effect and be in force five (5) days after its enactment by the Board of Supervisors of the Township of West Hempfield as provided by law.
