- E. <u>Treasurer</u>: Edward Fisher moved, seconded by Robert Munro to *appoint* Township Treasurer, Andrew Stern, as Treasurer. Motion passed (5-0).
- F. <u>Assistant Treasurer</u>: Edward Fisher moved, seconded by Robert Munro, to *appoint* Assistant Township Treasurer, Brenda Baumbach as Assistant Treasurer. Motion passed (5-0).
- G. <u>Solicitor</u>: Edward Fisher moved, seconded by Robert Munro to *appoint* Josele Cleary of Morgan, Hallgren, Crosswell & Kane as Solicitor. Motion passed (5-0).
