**RESOLUTION NO. 4-18**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF WEST HEMPFIELD TOWNSHIP ACKNOWLEDGING THE JOINDER OF A MUNICIPALITY TO THE AGREEMENT AMONG THE TOWNSHIPS OF EAST HEMPFIELD, EAST LAMPETER, MANOR, AND WEST HEMPFIELD AND THE BOROUGH OF COLUMBIA DATED JULY 19, 2014.

WHEREAS, the Townships of East Hempfield, East Lampeter, Manor, and West Hempfield and the Borough of Columbia (collectively the "Municipalities" and individually a "Municipality") entered into an Intergovernmental Agreement dated July 19, 2014, (the "2014 Agreement") providing for the formation of and participation in the Crash Scene Unit; and

WHEREAS, The 2014 Agreement provided a procedure for other municipalities to join the Crash Scene Unit; and

WHEREAS, West Lampeter Township has requested to become a member of the Crash Scene Unit and has enacted an ordinance under the Intergovernmental Cooperation Act accepting the terms of the 2014 Agreement, which ordinance was enacted February 12, 2018, and is designated as Ordinance No. 250; and

WHEREAS, West Lampeter Township has provided an executed Joinder Agreement to all municipalities who are parties to the 2014 Agreement; and

WHEREAS, the 2014 Agreement provides that upon receipt of such ordinance and executed Joinder each Municipality shall provide a list of all police officers to all of the other participating Municipalities and shall adopt a resolution in accordance with the Second Class Township Code or the Borough Code, as applicable, appointing the members of the Police Departments of the other participating Municipalities as police officers with jurisdiction in accordance with applicable provisions of the Second Class Township Code or Borough Code; and

WHEREAS, the Board of Supervisors desires to adopt such resolution.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Board of Supervisors of the Township of West Hempfield, Lancaster County, Pennsylvania, as follows:

Section 1. The foregoing background recitals are incorporated into and made a substantive part of this Resolution.

Section 2. The Board of Supervisors hereby appoints the members of the Police Departments identified in Exhibits A through F, all of which are attached hereto and incorporated herein, as police officers with jurisdiction within this Township to take all actions necessary or desirable to implement the 2014 Agreement. The listing of the police officers of this Township in the exhibits is intended to provide notice to the other participating Municipalities of such officers and is not intended to expand or lessen the jurisdiction of or assignments of such officers, who remain subject to the supervision of the West Hempfield Township Chief of Police.

Section 3. The Township Secretary is authorized to provide copies of this Resolution to all Municipalities participating in the 2014 Agreement.

Section 4. In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Resolution, it being the intent of the Board of Supervisors that the remainder of the Resolution shall be and shall remain in full force and effect.

Section 5. This Resolution shall take effect and be in force immediately.
