# A. Funk Investment Properties LP-WHTPC 04-19 Petition to Amend the Zoning Ordinance

Mark Stanley and Peter Werts of McNees, Wallace & Nurick LLC with Bill Swiernik of David Miller/Associates, Inc. informed the members the applicant Funk Investment Properties L.P. is proposing a petition to amend the West Hempfield Township Zoning Ordinance, Chapter 145, to permit dwellings in combination of commercial building in limited conditions in the neighborhood commercial district. This will provide greater flexibility in developing properties in the C-1 Zoning District for a mix of residential and commercial uses.

<u>Motion</u>: A motion was made by Mr. Stuckey, seconded by Mr. Carter, to recommend approval of the petition to amend the West Hempfield Township Zoning Ordinance for the C-1 Zoning District as written to the Board of Supervisors. **Carried 5-0.**
