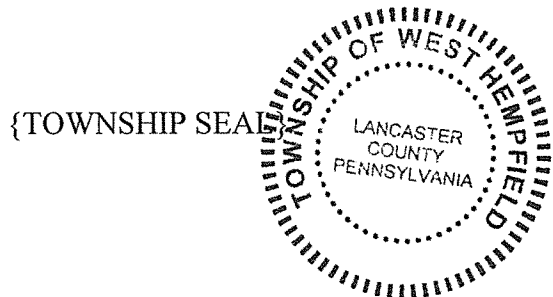
SECTION 2. That any resolution conflicting with this resolution is hereby repealed insofar as the same affects this resolution.

RESOLUTION NO. 20-2017

A RESOLUTION OF THE TOWNSHIP OF WEST HEMPFIELD, LANCASTER COUNTY, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2018.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of West Hempfield Township, Lancaster, Pennsylvania:

THAT a tax be and the same is hereby levied on all real property within West Hempfield Township subject to taxation for the fiscal year 2018 as follows:

SECTION 1. Tax rate for general purposes, the sum of 1.45 mills on each dollar of assessed valuation, or the sum of \$0.145 on each one hundred dollars of assessed valuation.

SECTION 2. All other municipal tax rates are to remain unchanged.


SECTION 3. That any resolution, or part of resolution, conflicting with this resolution be and the same is hereby repealed insofar as the same affects this resolution.
