A RESOLUTION OF THE TOWNSHIP OF WEST HEMPFIELD, LANCASTER COUNTY, PENNSYLVANIA, ACCEPTING ARCHER LANE AS PART OF THE PUBLIC ROAD SYSTEM OF WEST HEMPFIELD TOWNSHIP.

WHEREAS, a plan of Archer Lane has previously been submitted to and approved by the Board of Supervisors of West Hempfield Township; and

WHEREAS, Archer Lane has been constructed in accordance with such approved plan which was recorded at Document No. 2013-0028-J, in the Recorder's Office in and for Lancaster County, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of West Hempfield Township, Lancaster County, Pennsylvania, as follows:

Section 1. Archer Lane, as described in Exhibit "A" which is attached hereto and incorporated herein by reference, shall be and hereby becomes a part of the public road system of West Hempfield Township.

Section 2. A draft of Archer Lane is attached as Exhibit "B", and made a part hereof, in accordance with Section 2316 of the Second Class Township Code showing the following:

A. The street to be dedicated is Archer Lane.

B. The centerline length of Archer Lane is 958.96 feet, beginning at its intersection with Sylvan Retreat Road and ending at the Phase 1 termination at the northern property line of Lot 57.

C. Archer Lane has a right-of-way width of 50 feet and a cartway width of 28 feet.

Section 3. The proper officials of the Township are hereby authorized to do and perform all acts necessary and required under the Second Class Township Code and the Act of Assembly allocating fuel taxes to municipalities (72 P.S. §2615.1 et seq.) to accept such street as part of the

public road system of West Hempfield Township.

Section 4. All recording and filing costs relating to the acceptance of Archer Lane as part of the public road system of West Hempfield Township shall be paid by the owner-subdivider.
