## TRASH & RECYCLING CALENDAR

**SATURDAY, APRIL 13TH**

### LARGE APPLIANCE / TIRE PICK-UP:

■ Each large appliance must be marked with a Blue tag – \$12.00. Rimless tires must have **one** Yellow tag attached – \$1.50. Tires with rims must have **two** Yellow tags – \$3.00.

■ Items should be placed curbside on Friday evening, April 12th.

■ Purchase your tags **before NOON on Thursday, April 11th.**

■ If you have already purchased the necessary tag(s) and are disposing of an appliance, tires and/or rims, please register your name and address with the Township Office **before NOON Thursday, April 11th** to ensure pick-up.

■ If your items were missed on Saturday, April 13th, leave the items curbside and call the Township Office on Monday, April 15th after 8:00 a.m., or leave a message on the Township's voicemail.

■ After the April pick-up, the next large appliance / tire pick-up is Saturday, October 12, 2024.

### Holiday Trash Delays:

Memorial Day and Labor Day- Wednesday customers will have collection on Thursday, Thursday customers will have collection on Friday. Independence Day: No delay for Wednesday customers. Thursday customers will have collection on Friday.

### Yard Waste:

Yard waste will be collected on the same day as your regular trash service and will run from April through Early December. Yard waste **MUST** be in your own brown Kraft bags with \$1.50 Green Tag. Bundles of sticks, no more than 4' in length and 30 lbs., also require a Green Tag.

# ROAD PROJECTS FOR SUMMER 2024

### PAVING:

When the weather gets nice, our Public Works Department will be hard at work improving some of our roads. Roads receiving a face lift this year include: Oswego Drive, Oak Hollow Drive, Stone House Lane, Quarry Drive, S. 16th Street, 462-Manor, S. 18th Street, and Blue Lane.



## IMPROVEMENTS AT PROSPECT AND FAIRVIEW

As many of our residents know, there are a significant number of vehicular accidents on Prospect Road north of Route 30. This portion of Prospect Road is a state road, under the jurisdiction of PennDOT. The Township has spent the past several years petitioning PennDOT for improvements. Improvements which have been approved include:

- Elimination of trucks over 45 feet in length.
- Reduction of speed north of Ironville Pike.
- Relocation of the house at Concordia and Prospect to increase visibility.
- Surface treatment to increase friction and reduce sliding off roadway (Spring 2024).
- Additional improvements, possibly to include barriers on both sides of the curve, increased signage, and center rumble strips (Summer 2025).

Acquiring funding for projects on state roads is a long and slow process. We appreciate your patience as the Township continues to work to make our Township safer.

## WOODY WASTE OPENS APRIL 1ST

The Woody Waste Facility opens April 1st for the season. The facility will be open 7 days a week, from dawn till dusk. The site is gated and requires an access card to enter. This allows residents to enjoy greater flexibility to use the site during daylight hours.

The cost for an access card is \$15 per year and is valid from April 1st to December 31st of the calendar year. One access card may be purchased per household. If an access card is lost and needs to be replaced, there will be a replacement fee of \$20.

Invoices for the renewal of the cards in 2024 have been mailed. Payment can be made at the Township Office with cash, check, or credit card (bank convenience fee applies for credit card transactions).

## Septic System Maintenance

West Hempfield Township has a 3-year Septic System Pumping Cycle which is in accordance with PA DEP regulations. At the end of each year, we are required to file a year-end report with DEP.

A blue postcard was sent to residents that need to pump septic systems in 2024. Red postcards were sent to those who are past due for septic pumping. If you have received a postcard, but have already had your septic pumped, please call your septic hauler and ask them to send us the report. Many Septic Pumping companies will send the pumping report to the Township, but you can always check with us to ensure that we have received it. You can find a list of approved septic haulers on our website.

The postcard mailing isn't fool proof. It is ultimately the property owners' responsibility to ensure that their septic system is properly maintained.



## WATER LINES

In accordance with the recently revised US EPA Lead and Copper Rule, the City of Lancaster has initiated action to inventory all Water Service Lines within their service territory. This Inventory must be completed by **October 16, 2024**. If the City of Lancaster is your water service provider, you should have received a letter with your October and November utility bills asking all water customers to verify their service line material. ## Rt. 462 Veterans Memorial Bridge

The Rt 462 Veterans Memorial Bridge, originally built as the Lancaster-York Intercounty Bridge, also referred to as the Columbia-Wrightsville Bridge, is quite the bridge. Construction started in 1929 and it was officially opened on September 20, 1930. At 1.26 miles long, it is considered the longest concrete arch bridge in the world. Until the 1940's, when the bond was paid off, vehicles used to have to pay a \$0.25 toll to use the bridge. Most people don't realize that while 462 is a state road and PennDOT is responsible for the maintenance on the bridge, it is actually located in West Hempfield Township. And another fun fact is that it is on the National Register of Historic Places.

Currently the bridge is slated for a \$221 million project and has a 10 ton weight limit imposed until the work is completed. The purpose of the project is to ensure the structural adequacy and modern functionality of the bridge. The scope of the work for the bridge rehab includes deck and barrier replacement and strengthening and repairs to the bridge underside. There are 4 additional area enhancements that have also been identified:

1. Connecting Bike Route "S" and pedestrians to the Columbia Borough's Northwest River Trail and River Park
2. Connecting Bike Route "S" and pedestrians to Wrightsville Borough's Mason-Dixon Trail and Riverfront park
3. Construction of a roundabout at the western end of the bridge
4. Adding a traffic calming median feature at the eastern end of the bridge

The project is currently in the preliminary design phase, and work is anticipated to go to bid in 2026 and take approximately 5 years to complete.

## SPEED

The Township routinely receives complaints about speeding in neighborhoods. In response, our Police schedule the road for increased patrols and speed studies based on standards set by PennDOT. These studies usually show 85% or more of drivers are compliant. Many residents seek physical improvements, such as speed bumps and rumble strips. In general, these do not resolve the problem, only increase it and make road maintenance more complicated. The Township continues to closely monitor areas of concern.

# Stormwater and Illicit Discharge and Detection Elimination (IDDE)

Illicit discharges are defined as any type of flow found in the Municipal Separate Storm Sewer System (MS4) that is not composed entirely of stormwater. These discharges can enter the system through illegal connections, intentional dumping, accidental spills, or through cracks in stormwater pipes. Sewage contamination, a common example of an illicit discharge, can occur when a resident or business owner makes an illegal connection of the sanitary sewer system into the stormwater system. Illicit discharges are a major source of water pollution and can be extremely toxic to stream ecosystems because the pollutant/pathogen load is not diluted by stormwater. Eliminating illicit discharges into waterways is a key component of West Hempfield Township’s strategy to improve water quality. What is an Illicit Discharge? Examples of an illicit discharge is anything entering the MS4 that is not stormwater including: trash, paint, gasoline, oil, cleaning products, sewage, soil, leaves, grass clippings and many other items.

## What Can You Do to Reduce Illicit Discharges?

- Contact the Township or County for household hazardous waste drop-off locations and times.
- Clean up spills on paved surfaces as soon as possible using cat litter or other absorbent material. And then remember to clean up the absorbent material.
- Read chemical labels and purchase non-hazardous options when possible.
- Call the Township if you observe illegal dumping or if you see someone pouring/dumping something into a storm drain, ditch, or a stream.
- Never place yard waste in a drainage swale, stormwater basin, along a stream, or in a stream.
- If you have an on-lot septic system, have it inspected regularly.

## What is the Township Doing to Identify and Reduce Illicit Discharges?

- Regularly inspects the stormwater system and pipe outfalls to detect signs of illicit discharges. A pipe outfall is the location where stormwater runoff discharges into a stream.
- Makes repairs of the stormwater system as soon as identified to reduce stormwater pollution.
- Enforces erosion and sediment control requirements for all earth disturbance activity.

## Are there any Exceptions? Yes, the State Department of Environmental Protection (DEP) has identified the following exceptions:

- Discharges from firefighting activity.
- Discharges from waterline and fire hydrant flushing.
- Non-contaminated irrigation water, water from lawn maintenance, landscape drainage.
- Diverted stream flows and springs.
- Non-contaminated pumped ground water and water from foundation and footing drains and crawl space pumps.
- Non-contaminated HVAC condensation and water from geothermal systems.
- Residential vehicle wash water where cleaning agents are not utilized.
- Non-contaminated hydrostatic test water discharges.



As spring is right around the corner and homeowners are getting out the lawn mowers, it is important to remember the **DO's** and **DON'Ts** of grass clippings.

### DO:

- Mulch
- Let short clippings on the lawn, or
- Collect and compost clippings

### DON'T:

- Put in trash
- Blow onto roads, or
- Dump into storm sewers or streams

Short grass clippings left on the lawn act as free fertilizer for your lawn. Collected grass clippings can also be composted but they should never be placed into the trash stream. It is important to not blow grass clippings onto the roadways. This unexpected road condition, particularly concerning motorcycles, could cause a potential serious injury or fatal crash. In addition, grass clippings should not be placed into storm sewers as they are considered an illicit discharge. Storm sewers ultimately connect to a waterway. Grass clippings in our waterways contribute to nitrogen and phosphorus getting into the water. This contributes to algae growth and aquatic weeds moving downstream and into the Chesapeake Bay. Be a good neighbor to those downstream.

## Community Gardens

West Hempfield Township has been considering the addition of a community garden. Residents would be able to rent 20'x20' garden plots. ## Twp. Roads & Right-of-Ways

Spring is the time for projects! Please keep in mind before planning your next project that you need to consider having space to store materials on your property. Although it may be a convenient area to deliver items, the storing or staging of material on the public street or right-of-way is NOT permitted. Even if it's just for a couple hours or a day or two, do NOT place dumpsters, mulch, stones, soil, or building materials in the street.

## Who Owns The Roads?

At the Township Office, we get asked a lot of questions about our roads. Residents will often bring to our attention safety issues and ask the Township to upgrade a road, maintain a road, install signage or speed humps, or give us “pointers” about snow plowing. Roads in the Township are either privately owned, Township owned, or state owned. The ownership of the road plays a huge role in what the Township can or cannot do. The Township has no control over plowing, maintenance, or upgrades to private or state roads. But even if the road is owned by the Township, the installation of most traffic control devices must conform to the PA Motor Vehicle Code and related publications. In many cases, changes and improvements must be supported by an engineering study or significant justification. Below are some traffic control signs and devices and what is required in order to install them.

- **Stopping, Standing, and Parking Restriction Signs:** Must show that certain conditions have been met.
- **Stop or Yield Signs:** Specific traffic volume guidelines must be met. Stop signs cannot be erected for the sole purpose of reducing speed.
- **Traffic Lights:** Must conform to PennDOT “warrants” which address such issues as traffic counts and accident history.
- **Speed Limit Signs:** Engineering and traffic studies are required.
- **Pedestrian Crossing Signs:** A pedestrian needs study must be completed.
- **Truck or Weight Restriction Signs:** Structural analysis and engineering judgement is required.

On state roads (Marietta Ave, Columbia Ave, Old Harrisburg Pike, Stony Battery Rd, Prospect Rd, Spooky Nook Rd, Rt 441), issues are even more difficult to resolve. The only traffic control devices that the Township can install, revise, or remove without PennDOT approval include:

- Street names signs
- Crosswalk markings
- Curb markings at intersections
- Parking meters
- Stopping, standing, or parking restrictions

While we want to hear from our residents about street safety, and will work towards a solution, due to the complicated rules and regulations, these things often take significant amounts of time to resolve. We thank you for your patience.
